## Travel Terms and Conditions (Excerpt)

### 1. Package Tour Contract

This tour is planned, organized, and operated by Travel Link Co., Ltd. ( “the Company” ). Customers participating in this tour enter into a Package Tour Contract with the Company. The contents and conditions of the contract are based on the terms described in the tour advertisement (such as this brochure), the conditions listed below, the final itinerary, and the Company’s “General Terms and Conditions (Package Tour Contract).”

### 2. Application for the Tour

(1) Please fill out the application form and submit it together with the required deposit shown below for each participant. The deposit will be applied toward the tour price, cancellation fees, or penalty fees. If you require special assistance when participating in the tour, please inform us at the time of application. The Company will accommodate such requests to the extent possible.

(2) Applications may also be made by phone, mail, fax, or other communication methods. In this case, the contract is not yet concluded at the time of reservation. Please submit the deposit (20% of the tour price up to the full tour price) within three days from the day after the Company notifies you of the reservation acceptance.

### 3. Contract Conclusion and Delivery of Documents

(1) The Package Tour Contract is concluded when the Company accepts the contract and receives the deposit mentioned above.

(2) Notwithstanding the preceding clause, contracts made through communication methods are concluded when the Company issues a notification of acceptance. However, if the notification is sent by e-mail or similar electronic means, the contract is concluded when the notice reaches the customer.

(3) After the contract is concluded, the Company will provide documents (the “Contract Document” ) that specify the itinerary, details of travel services, travel conditions, and items regarding the Company’s responsibility. (This brochure constitutes part of the Contract Document.) The scope of travel services arranged and managed by the Company will be stated in the Contract Document.

*If the minimum number of participants is not met, the tour may be canceled. Customers will be notified no later than five days before the tour start date.*

*The General Travel Services Supervisor is responsible for handling travel transactions. If you have any questions regarding this contract, please feel free to ask.*

*These travel conditions are based on the standards as of December 20, 2024.*

### Handling of Personal Information

The Company will use the personal information provided on the application form (such as name, address, and telephone number) for communication with the customer and for arranging transportation, accommodation, and other services required for the tour.
